Additionally, a shared communication channel among all departments was also proposed, to ensure preparedness and the collaboration of efforts during emergencies. Tom Noon has offered to be Internim Emergency Management Director until a permanent director is appointed. Each agency will come together to form a committee to meet regularly and begin the process towards the development of an emergency response plan for the County.
