Open comments:

- Ray County Resident, Kurt Croix, expressed concerns about the condition of his road on W 141st Street in Rayville. He reported that water is not properly flowing into the culvert due to a ditch in front of his driveway and added that vehicles are shaking from the wash boarded road surface. Commissioners will get in touch with Road & Bridge to bring these concerns.

Commissioner Hockemeier made a motion to approve the minutes. Commissioner Davis 2nd the motion. Carried 3-0.

Commissioners approved payables from Payables Clerk, Trina Hudson and Treasurer, Melissa Holloway.

Commissioners signed Progress Invoice No. 15 for Christian Road Bridge No. 10900071, Project No. BRO-B089 (28).

Zachary Olivas, Project Manager, and Lindsey Chaffin, Vice President, both with Great River Engineering, met with Commissioners to present a formal report for Bridge No. 4020015, over the Henrietta overpass. The report included two proposed alternatives for replacement of the bridge and a third option consisting solely of removal. The proposed alternative with cost estimates are as follows:

1. Prestressed concrete girder bridge with a pedestrian sidewalk – estimated cost: \$9 million
2. Prestressed concrete girder bridge without a pedestrian sidewalk – estimated cost: \$8 million
3. Removal of the existing bridge without constructing replacement (demolition plan) – estimated cost: \$572,150.00.

Great River Engineering has expressed their willingness to work with the Commission on whichever option is determined to be in the County's best interest, and to assist in identifying the most cost-effective solution. The Commission will continue to explore all available avenues, including potential national grant opportunities, and will thoroughly review all information to determine the option that best aligns with the County's long-term goals and needs for bridges with Great River's support. Zachary also provided an update on the Myers Bridge project, which has been extended due to a delay in receiving the Railroad's reviews of the bridge layout. Final design work cannot proceed until that review is completed. MoDot has been aware of the delays and has approved.

Commissioner Davis made a motion to appoint Tammy Summers for the Ray County Hospital Board. Commissioner Hockemeier 2nd the motion. Carried 2-0. Commissioner Tracy recused herself from voting on the motion.

Commissioner Hockemeier made a motion to pass a Proclamation recognizing the month of November as Family Caregivers Month as presented from AARP. Commissioner Davis 2nd the motion. Carried 3-0.

Other business:

- Commissioner Hockemeier provided an update regarding the smaller bridge on Buffalo Road, which was previously discussed from the Commission meeting on Thursday, September 25, 2025. He contacted MoDot about the process for obtaining a floodplain permit and was informed that someone would need to be designated as a FEMA floodplain agent. Commissioner Hockemeier volunteered for the role. Commissioner Davis made a motion to designate Commissioner Hockemeier as a FEMA floodplain administrator for the County. Commissioner Tracy 2nd the motion. Carried 2-0.
- Commissioner Tracy read a letter of appreciation from Clinton County that recognized the Ray County Clerk's office and Deputy Clerk Kathy Dugger for all of their help and guidance with payroll last week, ensuring that Clinton County employees were paid on time during a challenging period. Clinton County expressed their sincere gratitude for the support and help provided by Kathy and the Clerk's office.

However, he still retains his ability to detect drugs and gets along really well with the Department's other K-9. His primary role will be providing emotional support, helping individuals during times of stress and anxiety, and fostering community engagement. He is especially good with children and is able to sense stress in individuals almost immediately. Rowdy will remain federally certified each year, and his veterinary care will be either free or come at a minimal cost to the department. With his loving, warm, and playful personality, excellent health, and years of experience, Rowdy can be expected to serve the department and community for many years to come.





A final walk-through of the bridge was conducted on September 24, 2025, during which it was noted that the deck's strength had tested lower than expected. Two options were presented for how the County could proceed. The first option involved a cost deduction. The second option proposed waiting one year, with Decker Construction monitoring the deck for any signs of cracking and resealing it if necessary. Tom Decker has committed to the County that his company will perform bridge inspections and complete any necessary repairs identified during the inspection. Burns & McDonnell and Decker Construction expressed confidence in the integrity of the bridge, stating that the deck has continued to gain strength since the final walk-through and now believes it has reached the recommended 4,000 psi. The bridge is well-constructed and designed to accommodate two full truck lanes. MoDot was in full support for either decision by the County, noting that the bridge shows no other concerns and the deck strength continues to improve. Commissioner Hockemeier made a motion to reevaluate the bridge in one year. Commissioner Tracy 2nd the motion. Carried 2-0.
Commissioners signed Decker Construction Invoice No.1 for ARPA Project from Public Water Supply District #1.

- Kirk Bellis, along with several other residents from the Bruns Road neighborhood, met with Commissioners to receive an update on the status of 84th Street Bridge at Bruns. The bridge has been closed for over a year and a half, with residents expressing growing frustration over the extended closure. Discussions addressed increased traffic and safety concerns along Bruns Road, as speeding has progressively become an issue and has created unsafe road conditions for drivers. The alternative route to 84th Street also experiences heavy traffic, and without the bridge, farmers are unable to move their machinery through the area efficiently. Residents noted that 84th Street, currently functioning as a one-way route, has frequent near-accidents and voiced concerns regarding the absence of progress towards the replacement of the bridge. The Commissioners assured residents that they have been actively pursuing all solutions in coordination with MoDot, emphasizing that the replacement of 84th Street Bridge at Bruns remains a priority for the County and its residents. While Commissioners did note that bridge replacement is a lengthy process involving significant coordination and funding challenges, they remain committed to identifying and moving forward with solutions for the replacement of 84th Street Bridge. They also plan to contact MoDot to request the clearing of brush along route 210 and Bruns to enhance visibility and improve driver safety.




Commissioners approved a payable to Stockton Builders for jail work under Capital Improvement from Ray County Treasurer, Melissa Holloway.


