Commissioners approved payables from Payables Clerk, Trina Hudson and Treasurer, Melissa Holloway.

Justin Wrisinger and Rob Swafford, both with Wrisinger Online Auction, met with Commissioners to present a proposal for management of the County's Surplus Auction that will be happening soon. They provided documents outlining their auction process and how it could be tailored to meet the County's specific needs. Discussion was held regarding what items would be included in the auction, advertising and promotional plans, and the next steps to move the process forward. Wrisinger Online Auction will handle phone inquiries, auction previews, and advertising efforts. After reviewing the proposed contract by Wrisinger, Commissioner Davis made a motion to approve and sign the contract from Wrisinger Online Auction to manage the County's Surplus Auction. Commissioner Hockemeier 2nd the motion. Carried 3-0.

Jeff Chronister and Bill Budnick, both with Ollis/Acres/Arney Insurance, met with Commissioners to discuss the upcoming mid-term renewal that they will be presenting soon. They inquired about any changes or updates from the County that should be reflected in the renewal. No new updates. Claims remain favorable for County facilities and properties, and the County will continue with Ollis/Acres/Arney for employee dental and vision coverage at the Courthouse. Both Jeff and Bill will be returning soon to present the renewal proposal to the Commissioners. Lindsey Chaffin, Vice President of Great River Engineering, met with Commissioners to provide updates on ongoing projects in the County. Lindsey also gave an update on the Myers Bridge project, where Great River is still waiting to hear from Union Pacific Railroad regarding the bridge layout approval before moving into its final design. Commissioners reviewed the Collector's settlement and approved abatements from Ray County Collector, Julie Chowning. Commissioners were also notified about the Senior Tax credit program for 2025 from Ray County Collector, Julie Chowning.


Commissioners signed letters to House of Hope and Synergy Services for the approved funds.

Commissioner Hockemeier made a motion to table the discussion of the LERF Board until further notice. Commissioner Davis 2nd the motion. Carried 3-0.


Commissioners had a Forvis meeting and received the following updates:

Commissioner Hockemeier made a motion to approve the 2026 RCSSB budget for the Ray County Senior Services Board.


Commissioner Davis 2nd the motion. Carried 3-0.

Commissioner Hockemeier made a motion to go into session. Commissioner Davis 2nd the motion. Carried 3-0.

Commissioners signed close-out documents for Christian Bridge No. 10900071, Project No. BRO-B089 (28).

Commissioner Hockemeier made a motion to approve and sign the amendment to the contract with Rapid Financial Solutions, LLC, for juror payment cards, presented by Ray County Treasurer, Melissa Holloway and Ray County Circuit Clerk, Michelle Woods.

Commissioner Davis 2nd the motion. Carried 3-0. The contract was extended for an additional three years, locking in the price of \$0.73 per juror card load. Juror payment cards help the courts accurately track and issue payments to jurors.

Commissioners and Major Tom Noon of the Sheriff's Department, discussed the proposed battery plant facility in Orrick. Significant concerns have been raised by both the County and local residents. Many Orrick residents have expressed serious concern about the battery storage facility and its proposed location adjacent to the City of Orrick, noting that it would represent a major change and disruption to the community of Orrick. To address these concerns, Major Tom Noon, who also serves as the Director of Ray County Emergency Management, recommended sending a letter of objection to the Orrick City Council regarding the project and the proposed annexation. His intent is to allow time for further research and to give the residents additional opportunity to voice their opinions and obtain answers. The Commissioners had also encouraged all residents to share their views directly with the Orrick City Council, as the Council may ultimately make the final decision. Commissioner Hockemeier made a motion to send the objection letter as presented by Major Tom Noon. Commissioner Davis 2nd the motion. Carried 3-0.

Major Tom Noon of the Sheriff's Department discussed the purchase of two higher-mileage fleet vehicles to replace two older Ford Explorers at the Sheriff's Department. He also presented a proposal to purchase a V8 Durango from Enterprise for the Ray County Public Administrator's office as their vehicle is no longer working.

Commissioner Hockemeier made a motion to purchase two higher-mileage Durangos from Enterprise for the Sheriff's Department.

Commissioner Davis 2nd the motion. Carried 3-0.

Commissioner Hockemeier made a motion to purchase a V8 Durango from Enterprise for the Ray County Public Administrator and to sell her current Ford Explorer. Commissioner Davis 2nd the motion. Carried 3-0.

Commissioner Hockemeier made a motion to lease two new vehicles for the Sheriff's Department to replace two existing leased vehicles from Enterprise. Commissioner Davis 2nd the motion. Carried 3-0.

Other business:


