Greg Braurer, with Hutchison Engineering, Inc, joined the Commissioner's meeting to introduce himself and the company.

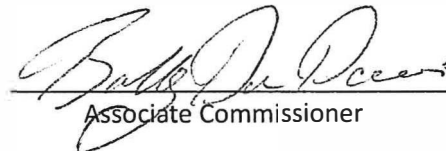
